



MAD qualifies six quartets for the big show in Las Vegas

Distinction takes District Seniors Quartet crown

Serendipity is Mixed Quartet Champion

13 ensembles participate in District Youth in Harmony adjudication

Our 2017 Spring Convention was one for the record books. Held this year at The Inn at Reading in Reading, Pa., the audience was small but highly encouraging. We had 21 competitors in the following categories: International Prelims (17); Mixed (3); Senior District Championship (3). We had two out-of-district quartets vying for a qualifying score of 76% or higher to attend the 2017 International Quartet Contest in Las Vegas. Our annual Youth Adjudication drew 14 youth quartets and ensembles.

When the dust settled the results were as follows:

International Preliminary Qualifiers from M-AD:

- *'Round Midnight* 84.4% (2025 pts)
- *Pratt Street Power* 81.4% (1954 pts) * First-time qualifiers!
- *Gimme Four* 81.4% (1953 pts)
- *Route 1* 80.9% (1941 pts)
- *Frank the Dog* 80.8% (1938 pts)
- *Forecast* 76.3% (1832 pts) * First-time qualifiers!

That's right! Six, count 'em SIX M-AD qualifiers for International. (another couple of likely qualifiers are competing outside of M-AD due to schedule conflicts with our contest.)

International Preliminary Qualifiers from out-of-district:

- Quorum (JAD) 88.1% (2115 pts)
- The Con Men (JAD) 79.6% (1910 pts)

Mixed Quartets

- 1st Place: Serendipity 70.3%
- 2nd Place: Sum of Each 65.8%
- 3rd Place: Mouthnoise 60.8%

M-AD Senior District Champions

- Distinction 67.5%

These results made for a very entertaining Jamboree on Saturday night. The new District Senior Quartet Champions sang, as did the Mixed Quartet champs and our two female mic tester/mic cooler quartets for the weekend Sweet Lucy and Brown-Eyed Girls.

Then the International qualifiers were announced, as has become the tradition in recent years, via the appearance of the "vessel" from behind the curtain. The "vessel" appears in different forms throughout its appearances and contains the name of the next International qualifier. A long as

the "vessel" appears, there is another qualifier. Happily, the "vessel" did not disappoint!

Once a qualifier's name is announced they are invited to the stage to sing one song. Nearly everyone seems to enjoy this...the quartets find it a bit nerve-wracking. Oh well.

The "Audience Favorite" Awards were back this year, however, there were some new twists. Gone are the days of paper and pencil voting. This time, voting was done electronically via smart phone, tablet or laptop and software called "EZVOTEONLINE.COM", created by our own

Webmaster and IT guru, Mike Kelly. Easy to use and a huge time saver, this made for MUCH easier tabulation at the end. Awards were, as always, cheesy, but highly coveted.

Youth Festival rocks!

This year's Mid-Atlantic District youth adjudication featured 12 quartets and two "very large quartets," the Wildcat Harmonizers from Quinton Township School, directed by John Wernega, and Pieces of Eight from Phillipsburg High School, directed by Debbie Keretz. Two high schools and two middle schools sent participants to the event.

Every year the quality of these youth performances improves and this year was no exception. We saw some remarkable performances. In past years, Tamanend Middle School has sent some wonderfully talented boys quartets to the festival. They were notably absent this year – because they all had graduated!

So, choral director **Ian Sanchez** threw out the possibility of forming quartets for the pre-imp weekend to his female students. Following the school's spring musical production just two weeks before the adjudication, the four quartets got busy.

In his 7th year as the Choral Director at Tamanend Middle School, a school of about 900 students in grades 7-9 located in Bucks County, Pa., Ian has become a barbershop fan. His students comprise three grade-level choruses and individual students may audition for the school select chorus and choose from other opportunities as well, such as the smaller (25 member) select chorus, county chorus, Star Spangled Banner solos, and the barbershop program.

Barbershop, you say? We'll let Ian tell you about it in his own words:

"For many years, The Bucks County Chapter of BHS (Country Gentlemen) has had a strong relationship with another middle school in our school district, Lenape Middle School in Doylestown, as they use the school's facilities for rehearsal and concerts. Lenape has had boys and girls ensembles for many years, one of whom, the Acabellas, travelled to Harmony College East last June. Their director, Jaime Rogers (jrogers@cbsd.org), does a great job!

"In 2012, the Country Gentlemen created a Youth in Harmony Quartet Festival for boys and directed it first toward the 5 middle schools in the Central Bucks School District. The Gents have been so helpful each year – assisting with music selection, quartet coaching, and generally spreading the good that comes out of singing barbershop. None of us could really make barbershop happen the way we do without their help!"

"Since that time, most of the middle schools have had quartets participate in the festival. The first year, I handpicked my four strongest boys and created the 'Taminators,' who won the gold medal at the Festival and earned a scholarship to Harmony College East in June 2012 ([HERE](#) is a video of them rehearsing at HCE!). It was then that I really saw the true nature of the barbershop community – everyone was so supportive and helpful to the boys, and

we all had a great time!

"In the five years of the local quartet festival, my quartets have won 4 gold, 2 silver, and 2 bronze medals. Though they have been offered scholarships to HCE each year, scheduling issues prevented any quartets attending after the Taminators, until last June, when Who's the Bass? and the QuadraTONES attended.

"For many years, my girls have wanted to get involved with barbershop as well, but until this year, I didn't have the reason to pursue

it. The local YIH festival is just for boys, and there isn't quite enough support available from the Country Gentlemen to add girls quite yet. So,

when Kevin Boehm mentioned the MAD spring youth adjudications when I spoke with him at HCE, I thought this might be the perfect year to add some girl's quartets to my program.

"The girls were thrilled when I told them in the fall. I placed the girls in quartets earlier in the year, but the process of finding contestable Sweet Adeline music that was learnable by novice middle school barbershoppers, with learning tracks available was much more daunting than I had anticipated. I got started finding resources in the fall, but as much as I tried, I couldn't devote time to complete that process until after our musical closed on March 11th.

"When I double checked with the girls after musical, they were still excited to sing in quartets, so I continued the process, and finalized everything, giving them about 2 weeks to learn everything. They spent time on their own learning their parts, and we had 6 rehearsals, most for an hour and 45 minutes. I couldn't be happier with the results!"

"I put a good deal of time into getting the girls together, but I have to give credit to my family and my school administration for allowing me to follow through with my crazy ideas, and to the parents for being so supportive of my program. I'm so thankful that the Country Gentlemen (specifically Dave Ives and Erik Fleischer) brought barbershop into all of our middle schools 5 years ago. The large numbers of them who coach our quartets and their presence at numerous district events has been such a great positive force in our community. Their assistant director, Chas Bryam, also spent time working with our girl's quartets last week.

"Most of all, I have to give credit for all of my hard working students. The girls spent so much time learning their parts ahead of time and also had to lead large portions of their rehearsals, so I could spread myself around amongst all the quartets. My boys are always hard-working as well.

I feel fortunate to work in a great school with great kids and a very supportive community.

"I'm just thrilled I can get them hooked on singing in harmony!"

What's with the MAD Endowment Fund?

This year (as last) the Mid-Atlantic District Endowment Fund is offering scholarships to nine front line and assistant directors and one adult quartet to attend Harmony College East (HCE) and two youth quartets (and their sponsor) to attend the Youth Harmony Camp held simultaneously at the same location! Recipients will enroll in classes geared toward improving conducting skills, perfecting singing and performing abilities, and choose from a host of courses related to their individual needs.

How is the Fund doing? At the beginning of this year the Fund total exceeded \$198,400 – an increase of over \$24K from a year ago. WOW! This results from intentional giving by a host of individuals, chapters, and quartets plus investment earnings.

Contributions were received over the course of the year in the form of individual donations and through the "donor choice" option available from Harmony Foundation International (HFI) by members of the President's Council (PC) and Ambassadors of Song (AOS). Selecting the "donor choice" option when contributing to PC or AOS, offers contributors the ability to designate up to 30% of their donation to be returned to their chapter or the district or (in combination) to both. In fact, during

2016 over 100 individuals added a total of over \$12,500 to the Fund by exercising "donor choice."

To be clear, the Fund principal is never touched. Scholarships are provided only from the interest and dividends earned during the year.


Calling All Seniors

Now that the district rules have been aligned with those of the society, it is even more straightforward to find your path to greatness.

Left face, right face, about face . . .

How and why the selection process for MAD reps to the International Seniors Quartet Contest has changed

The way the Mid-Atlantic District chooses its official quartet representative to the BHS International Senior Quartet Contest held at the Mid-Winter Convention in January has changed a few times and is admittedly . . . confusing. To clear up the confusion, I will explain some of the history of the selection process and then conclude with how it will work this year and beyond . . . until it changes again.

A few years ago we selected our M-AD senior representative to the International Senior Quartet contest at our spring convention (aka "Prelims"). This worked well for us until the BHS changed the rules and all districts were mandated to select their representative at their fall conventions. We complied and selected the top 5 senior quartets overall from the spring contests (prelims and division) and advanced them to the Friday night round of the Fall District Convention's quartet contest.

When some of the smaller BHS districts changed to having only one contest each year the BHS relaxed the requirement that district senior representatives to the International Senior Quartet Contest be selected at fall district conventions. With that change, we went back to selecting the M-AD senior quartet representative from the overall senior quartet scores from all of the M-AD spring contests (prelims and the division contests).

In 2014, the BHS changed the rules again but we had already begun our spring convention cycle in M-AD so we were granted an exemption from the "newest" rules for that year. Unfortunately, we erroneously continued to conduct our senior selection process in that way in both 2015 and 2016. As of 2017, we

have been requested to comply with the current selection process, which requires that we select our senior representative to Mid-Winter at one contest with all senior quartets being scored and adjudicated by the SAME judging panel, at the same time. After discussions with the BHS Contest and Judging Committee that one contest will be our Fall District Convention in September.

As many of you know, our district is blessed with a plethora of quartets and choruses and we usually have 25 quartet competitors and 20-22 chorus competitors. Due to our wealth of competitors we use our division contests as a way to "qualify" our quartets and choruses for the Fall District Convention contests. We simply do not have the luxury of conducting an "open" contest for non-senior quartets or choruses . . . or senior quartets.

Thus, all of the M-AD senior quartets desiring to represent the M-AD at the International Senior Quartet Contest at the 2018 Mid-Winter Convention will need to have competed at one of the spring quartet contests (Prelims, Central, Southern or Northern). After the Northern Division quartet contest is completed, the top three (3) senior quartets (overall) who competed at the four (4) 2017 M-AD spring contests (no senior quartets competed in the International Senior Quartet Preliminary at the Spring Convention (aka Prelims) so this year the selection will be made from the three (3) division quartet contests) will be invited to compete at the M-AD Fall District quartet contest in September. Based on Friday night performance scores, the highest scoring senior quartet from the 2017 Fall District Quartet Contest will be

named the M-AD representative to the International Senior Quartet Contest at Mid-Winter. The second and third place senior quartets from that contest, based on their Friday night quartet contest scores, may be invited by the BHS to fill in the competition field at Mid-Winter as "wildcard" quartets.

Should any of the top three senior quartets from the M-AD spring quartet contests decline the invitation to compete at the M-AD Fall District Senior quartet contest, the next senior quartet(s), in order of finish at the three division contests (overall) will be invited to compete until a total of three (3) have accepted the invitation to compete. It is possible that some or all of the three senior quartet competitors who advance to the Fall District Senior quartet contest will have also qualified as non-senior quartets to compete in the Fall District quartet contest. This will not affect the number of three (3) senior quartets competing at the Fall District quartet contest.

Next on the program were laudatory remarks by Alex Laufer, president of the Fairfax Chapter. He noted that 1957 was a banner year for the Jubil-Aires. They performed in the International Chorus Contest and won the Mid-Atlantic District Championship. They also had the pleasure and honor of sponsoring the chartering of the Arlington Chapter.

Mid-Atlantic District President Dennis Ritchey,

although unable to be present, congratulated the Arlingtones by email. He noted that "the Arlington Chapter represents a long rich history of preserving and performing our beloved art form. ... The Arlingtones can be very proud of their legacy of entertaining shows, tireless outreach efforts to spread barbershop harmony throughout the local community, and continued engagement with the local arts community."

Coincidentally the inscription on the cake, "Enriching Lives Through Harmony," echoed the title of the plan for developing the Arts in Arlington: "Enriching Lives: Arlington Arts and Culture Strategy."

‘The best Valentine I’ve ever had’

Barbershop quartet serenades Hampton Roads

People stared as the four men in suits and shimmery turquoise bow ties huddled in the lobby of an office building.

Then Pat Patrick hummed and pulled out a pitch pipe, and the quartet started singing. “Let me call you sweetheart, I’m in love with you...”

Sure, you can send cards or flowers for Valentine’s Day. But why not say “I love you” with a song? Or rather, let some guys with much better voices say it for you.

For \$40 to \$60, depending on timing, you can order a song from the Acclaim! barbershop quartet, complete with a card and long-stemmed red rose. Chocolates or a dozen roses cost extra.

The huddle Tuesday morning marked the day’s first singing telegram for Acclaim!, one of several local quartets in the Norfolk chapter of the Barbershop Harmony Society. The all-male singing organization has some 30,000 members in North America.

Patrick, Dick DeLuca, Dave Watts and Van White piled into a white van for their annual scramble to deliver the singing valentines. They’ve been together for almost a quarter-century.

At an office off Kempsville Road, Board President Cliff Yellen had ordered a surprise for the staff at Susan G. Komen Tidewater.

The four walked in, handed Executive Director Sharon Laderberg a rose and sang.

“That was a beautiful surprise,” Laderberg said. “These guys have unbelievable voices.”

Singing’s the easy part. Getting to each gig around Hampton Roads, on time, can be harder.

Being flexible is key, Watts said.

DeLuca made calls from the van’s back seat Tuesday as the quartet reviewed the day’s schedule. Patrick’s wife, Peggy, acts as chauffeur,

allowing the men to pop in and out of the van when they arrive.

“It’s not as easy getting out of the van as it was 20 years ago,” Watts said with a laugh.

In addition to orders, they surprised a few friends at local nonprofits.

“Oh my God, hi!” said Joan Rhodes-Copeland, executive director of the Cultural Alliance of Greater Hampton Roads as she opened the door. “I’m glad I wore a nice outfit today.”

She swayed to the music. “This is the best Valentine I’ve ever had.”

On Tuesday, Jamin Casselman requested Acclaim! sing to his wife, Heather, an operating room nurse at Sentara Leigh Hospital.

“She’s going to be so embarrassed,” he said while they waited.

Heather Smith-Casselmann came out of surgery for the surprise in scrubs. As the quartet sang, people in the waiting room shot video with their cellphones. Afterward, they cheered.

“It was lovely,” Smith-Casselmann said.

Then the singers piled back into the van.

“So what’s next?” Patrick said.

Patrick beamed. “We get that all the time,” he said.

That’s what makes the rush worth it.

“It’s rewarding when you make someone’s day,” White said. “It’s better than balloons, it’s better than candy.”

“And you never know what’s going on in the lives of the people you sing for,” Watts said.

White even sang through intense tooth pain one time, tears streaming down his face. He got a root canal later that night.

The quartet’s gone up and down the region, from Gloucester to Suffolk, from an “uncomfortable” occasion singing to a construction boss on site to singing in classrooms and senior homes.

The importance of riser placement

Directors ask me all the time about placing singers on the risers. Most directors believe that riser placement is an important factor in helping to enhance the ensemble's sound, yet many do not know how to get started. There are important factors to consider, yet this is hardly an exact science, so

sometimes trial and error will help you decide the best riser placement for your chorus. My goal in this article is to delve into two

primary factors for consideration (should your singers stand in sections or all mixed up, and the importance of matching resonance and timbre for effective placement) and then list a number of additional issues to consider.

Sectional singing or shotgun?

Many directors want to know which method is "better": placing their singers in sections or mixing them up throughout the risers (often called a shotgun formation). There are several advantages to both placements, some of which are as follows:

Sectional singing:

- When singers are grouped in sections, they can more easily balance and blend within their section and learn to sing as one voice.
- In the short run, music is learned quicker.
- "Leaners" (singers who are less confident on their own and depend on stronger singers for support) can best assimilate into their sectional sound and sing confidently.
- One outstanding singer will tend to make the composite sectional sound better with regard to tone color and richness of sound.
- Proper balance among sections (sufficient bass and lead, appropriate levels of tenor and baritone, etc) is easily achieved by setting your sections on the risers accordingly.
- But please keep in mind that:
- Singers will not hear the barbershop sound as much when relegated to sections, so their ability to achieve

ideal intonation may be compromised.

- Singers will learn to become dependent on others in their section, which may result in your chorus sounding quite different if your attendance varies at rehearsals or performances.

Shotgun formation:

- Barbershoppers tend to prefer singing this way, as they can hear all of the parts around them.
- This formation develops independence in singers.
- Singers learn to listen a lot more in this formation.
- Intonation problems may be mitigated because one individual singing out of tune (especially flat) will not necessarily drag the entire section down with him.
- In the long run, learning music may be enhanced because the independence that a singer learns in this formation can generate a more aggressive approach to learning music.
- But please keep in mind that:
- Though some "leaners" will become stronger and more confident in a shotgun formation, a good number of others may feel overwhelmed and may hold back so as not to "mess everyone else up."
- Though barbershoppers prefer singing this way, this does not necessarily translate into a better sound from your chorus.

The importance of resonance and timbre in riser placement:

Singers have different vocal characteristics with regard to resonance and timbre. For ease of understanding, I will differentiate between three types of "inherent head resonance." The number "1" singer has the least resonance, number "2" has medium resonance, and the number "3" singer is most resonant. As for timbre, a number "1" voice is bright and/or strident, a "2" voice is well-balanced, and a "3" voice is dark and/or throaty. It is important to remember that this numbering system only has to do with resonance and timbre. It does not indicate a "good" voice or a "poor" voice whatsoever.

The key to using resonance and timbre in setting riser positions is that singers should stand next to a singer of like or similar resonance and timbre. Once you have classified your singers within their sections, here are some guidelines in placing them on the risers:

- Place "3's" toward the center and the least resonant "1's" to the outside.

- "3's" are ideally not placed in the front row because their resonance may add weight to the tone. Best to place "3's" behind "2's", which adds depth to the "2's" resonance.
- "2's" are ideal in the front row
- Another option is to start from either the left or the right or the front or the back of the risers and put "3's" on one side, moving to "2's", then finally "1's" on the other side. Some directors alternate rows, going from dark to bright on one riser, then bright to dark on the next riser, etc. In all such combinations, the most important factor is not to place two singers together who have differing resonance and/or timbre.

Additional considerations

Theory of threes:

- This concept suggests that, when two voices are singing, you can differentiate between the two, and when four voices are singing, you can pick out individual voices. But when three voices are singing, they seem to form a more composite sound that is pleasing to the ear.
- This system comes into play when you have three singers of a certain voice part singing together, all three in one row. Some directors choose to place singers in threes in a triangular formation: two singers next to each other in a row, and the third in between them one row down.
- This system works best in a shotgun standing formation.
- Of course, you will never have a perfect number of singers who fit into the theory of threes. There will always be singles, such as very good quartet singers or strongly independent singers who can sing their part no matter where they are placed. Fill them into open spots as you see fit.
- The theory of threes is based on the premise that each singer should not change the way he naturally sings. Meaning, he isn't trying to match anyone in the chorus but rather he is trying to sing his best using his natural voice type.

One common standing formation using the theory of threes is as follows:

Chorus of 36 members: (T = tenor, L = lead, b = baritone, B = bass)

Should your singers stand in sections or all mixed up?

Various vocal characteristics and some thoughts about them:

- Voices that blend well fit in quite nicely in the 2nd row.
- Voices that do not blend well (large vibrato, extremely big voices, "unique" voices, etc) are good candidates for the 3rd row. Additionally, these voices are best placed to either side of the chorus and should not be centrally located.
- Your front row may be made up of all light voices or all mature voices with carrying power. However, you should not mix and match light and mature voices in the front row, as there is a greater likelihood for individual voices to stick out.
- Insecure singers should not sing in the first or second rows (in choruses of four rows or more), and they should always be placed in between or in front of secure singers.

Regarding the performance category:

- Expressive faces are necessary in the front row and the middle of the chorus.
- Singers with strong performance skills should ideally be located in the back row and along the left and right sides of the chorus.
- The front row is comprised of select singers based on expressiveness, extreme believability in conveying the song's message, and timbre and resonance considerations.
- The tallest men are most often put in the back row.

Does all this sound complicated? Well, to some degree it is! But it may be to your advantage to consider some the concepts I touched upon to determine whether changes in your riser placement might benefit your chorus. If you try a new system and it doesn't produce the results you hoped for, then reevaluate and try again. At the end of the day you want your singers standing in a configuration where they feel the most comfortable and create the best sound. A new riser placement might just be the key to new levels of success for your singers.



Chuck Harner

Charles F. Harner (Chuck) passed away on March 1, 2017 at his home in Vienna, Va. Following a 25-year career in the United States Navy, Chuck worked for Booz, Allen Hamilton as Manager of Navy Logistics Training before retiring for good.

He was a 49-year member of the Barbershop Harmony Society (BHS) which was the passion of his life, after his wife Marjorie and children and grandchildren. During his barbershop career Chuck served as:

Chuck was a member of both the Alexandria Harmonizers and the Harmony Heritage Singers.

He was inducted into the MAD Honor Chapter (DELASUSQUEHUDMAC) in 1983 and into the MAD Hall of Honor in 2009.

Long time "dean" of the MAD Leadership Academy program, Chuck was actively pursuing certification as one of the BHS' new leadership trainers at the time of his death.
